

CONSULAR OFFICER

VISA INSTRUCTION

- 1. Consular hours 10.00 a.m. to 1.00 p.m. on all working days. Office closes Saturday, Sunday and announced official holiday. Minimum 24 hours required for processing of visa.
- 2. All visas are issued according to the stated PURPOSE OF VISIT which must be CLEARLY STATED by the applicant. Failure to do so shall inevitably incur delays.
- Do check your passport whether it is valid for over 6 months from the date of visa.
- 4. The visas issued by the Embassy or Consulates only give right to ENTER THE GAMBIA and must be used within 3 months from date of application.

5. HOW TO APPLY FOR A VISA

Complete and sign. ONE application form. A separate form.

Submit with the completed application form.

- Your passport/travel document which should be valid for at least SIX MONTHS from date of application.
- TWO recent photographs.
- The appropriate fees (see7)
- US\$ MUST BE ENDORSED IN THE PASSPORT/COPY OF CREDIT CARD/UNDERTAKING FROM EMPLOYERS.

6. An Entry Visa is granted in the following categories:

TOURIST VISA granted to those who are bonafied tourist of good standing and conduct for a stay in THE GAMBIA upto 60 days.

A TRANSIT VISA for stay in THE GAMBIA for few days is granted a person of adequate means travelling in transit through the Republic to other Countries.

FOR OTHER PURPOSE THAN TOURISM, please submit EVIDENCE SUBSTANTIATING YOUR PURPOSE OF STAY, Examples of such evidence are: in case of transit, a confirmed travel document (air ticket etc.) showing THE GAMBIA as a point of transit: in case of business trip, a letter from your employer and/or business counterpart in THE GAMBIA in case of work in THE GAMBIA, a letter of employment from your prospective employer.

7. VISA FEES

GRATIS FOR ALL INDIAN NATIONALS.

- 8. A person entering THE GAMBIA must have in his possession travellers cheques or in cash convertable money reasonable to the extent of stay or credit card.
- 9. One who applies for a kind of visa should not except to take benefit to other kind of visa upon arrival in THE GAMBIA.

10. HEALTH REQUIREMENTS (SUBJECTS TO CHANGES)

Persons holding passports of or having residence in countries in the Yellow Fever area must produce a valid international health certificate for Yellow Fever at point of entry into THE GAMBIA.
